ORDER

Subject: Citizen Feedback and Suggestion Initiative for Improvement of Chandannagar City ("Amar Chandannagar, Amar Bhabna")

In order to strengthen citizen participation in urban governance and to make municipal administration more responsive, transparent and people-centric, Chandernagore Municipal Corporation hereby launches a special public initiative titled "Amar Chandannagar, Amar Bhabna".

The objective of this initiative is to invite feedback, suggestions and innovative ideas from citizens, students, resident welfare associations, market committees, clubs, NGOs, professionals, educational institutions and other stakeholders for improving civic services and overall urban management of Chandannagar.

The suggestions may relate to, inter alia, the following areas:

1. Cleanliness and solid waste management
2. Drainage and monsoon preparedness
3. Roads, footpaths and streetlights
4. Water supply and public sanitation
5. Traffic, parking and market management
6. Heritage conservation and tourism promotion
7. Ganga riverfront, ghats, parks and public spaces
8. Beautification, wall painting and urban greenery
9. Women safety, public toilets and safe public spaces
10. Digital municipal services and grievance redressal
11. Revenue improvement and better delivery of municipal services
12. Any other practical idea for city improvement

Citizens may submit their suggestions through online and offline modes, including Google Form/QR code, email, WhatsApp, suggestion boxes at designated municipal locations, ward-level collection points and special outreach camps.

Each suggestion shall contain, as far as possible, the name of the applicant, ward number, mobile number, address/locality, category of suggestion, brief description of the issue or idea, exact location, photograph if available, expected public benefit and willingness to participate as a volunteer, if any.

For proper scrutiny and evaluation of the suggestions received, a City Ideas Evaluation Committee is hereby constituted as follows:

2. Sub Divisional Officer, Chandannagar — Member
3. Municipal Commissioner — Member

The Committee shall evaluate the suggestions on the basis of feasibility, public benefit, cost-effectiveness, visible impact, innovation, heritage value and replicability across wards. The Committee may also seek inputs from concerned departments before finalising recommendations.

The best suggestions shall be suitably recognised and rewarded by Chandernagore Municipal Corporation. Selected ideas may also be taken up for pilot implementation, subject to administrative feasibility, availability of funds and approval of competent authority.

All Heads of Departments, ward-level functionaries, sanitary inspectors, engineers and concerned municipal staff are hereby directed to give wide publicity to this initiative and ensure maximum public participation. Public notices, banners, posters, social media posts and QR code-based submission links shall be widely circulated.

The initiative shall be implemented in the following manner:

1. Start Date: 15/06/2026
2. Collection of Suggestions: 15 days from the date of launch [From 15.06.2026 to 29.06.2026]
3. Screening and Evaluation: Within 7 days after closure of submissions [From 30.06.2026 to 06.07.2026]
4. Declaration of Selected Ideas and Awards: On a date to be notified separately
5. Pilot Implementation of Selected Ideas: As per feasibility and approval
6. Such Suggestion boxes will be placed in JKS

The IT Nodal Officer shall create and maintain a digital database of all suggestions received. The General Administration section shall coordinate with all departments for compilation, scrutiny and record keeping.

This order shall take immediate effect.
